**Swimming Pools, Spa and Therapeutic Pools:** Algae Aid Algacide must be used with a registered sanitiser when the pool is used for bathing. To prevent the water appearing hazey the product should NOT be added for at least 48 hours after super chlorinating the pool. However, during normal dosing this time delay is not required. Use product monthly or if under high bathing load use weekly.

For spa baths, use in conjunction with a cleaning product (Calculate the volume of a pool by multiplying the length x width x depth of pool in metres x 1000 to give the volume in litres).

**WINTER MAINTENANCE**

If pool is sanitised using chlorine, treat pool every 3-4 weeks. After application of the product filter water for 12 hours to ensure mixing, brush pool walls thoroughly and vacuum. Only use high dosage rates when pool is not in use e.g. heavy algae and winter dose rates.

**For general Algae and Mould control:** Clean the surface with an appropriate cleaner such as Cyndan "Cleans All" or Cyndan "Concrete Wash" (see your Indigo Representative). Apply the solution of Algae Aid Algacide to the cleaned surface and allow to dry. This will stop spore growth and maintain a clean, presentable surface. Cyndan "Masonry Sealer" may be applicable in sealing the clean surface. See your Indigo Representative for more information.

**For grasses and vegetation:** Algae Aid Algacide is ideal for golf course and bowling greens, bunkers and sports turf areas.

**For Pigeries, Hatcheries and Dairies:** Use Algae Aid Algacide as a sanitiser after precleaning with a cleaner such as Cyndan Farm Mate or Power Kleen. Refer to General Use section of Table for application rates.

For establishments requiring the use of the product under the Commonwealth Export Control Act rinse product contacting surfaces with potable water after use.

**Caution:** Not to be used as a food container.

**STORAGE AND DISPOSAL**

Store in the closed, original container in a cool, dry place out of reach of children. DO NOT store in direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. DO NOT burn empty containers or product.

**SAFETY DIRECTIONS**

Will irritate the eyes, nose, throat and skin. Avoid contact with eyes and skin. DO NOT inhale vapour.

**FIRST AID**
