## **DIRECTIONS FOR USE**

### **RESTRAINTS**

DO NOT apply with aircraft.

DO NOT apply through any type of irrigation equipment.

### **SPRAY DRIFT RESTRAINTS**

DO NOT apply with spray droplets smaller than a MEDIUM spray droplet size category according to nozzle manufacturer specifications that refer to the ASAE S572 Standard or the British Crop Production Council Guideline.

DO NOT apply when wind speed is less than 3 or more than 20 kilometres per hour as measured at the application site.

DO NOT apply during surface temperature inversion conditions at the application site.

Users of this product MUST make an accurate written record of the details of each spray application within 24 hours following application, and must KEEP this record for at least 2 years.

The spray application details that must be recorded are:

1. Date with start and finish times of application;
2. Location address and paddock(s) sprayed;
3. Full name of this product;
4. Amount of product used per hectare and number of hectares applied to;
5. Crop or situation and weed or pest;
6. Wind speed and direction during application;

7. Air temperature and relative humidity during application;

8. Nozzle brand, type, spray angle, nozzle capacity and spray system pressure measured during application;

9. Name and address of person applying this product.

### **MANDATORY NO-SPRAY ZONES**

DO NOT apply if there are aquatic and wetland areas including aquacultural ponds, surface streams and rivers downwind from the application area and within the mandatory no-spray zones shown in the table below.

## GENERAL INSTRUCTIONS

### MIXING

Fill minimum 50% of the required water into the spray tank, and agitate when adding the required amount of Segway 400 SC Fungicide. Finally add the rest of the required water volume. Keep the spray solution agitated until all product is applied. Never prepare more spray solution than required.

### COMPATIBILITY

For information on the compatibility of Segway 400 SC Fungicide with other products, contact your local ISP representative.

#### GROUP 21 FUNGICIDE

For fungicide resistance management Segway 400 SC Fungicide is a group 21 fungicide. Some naturally occurring individual fungi resistant to the product and other group 21 fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungal population if these fungicides are used repeatedly. These resistant fungi will not be controlled by the product or other Group 21 fungicides, thus resulting in a reduction in efficacy and possible yield loss.
